

SUMMARY ANNUAL REPORT

For AEROVIRONMENT INC. EMPLOYEE BENEFIT PLAN

This is a summary of the annual report of the AEROVIRONMENT INC. EMPLOYEE BENEFIT PLAN, EIN 95-2705790, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

AEROVIRONMENT INC. has committed itself to pay certain self-insured Medical and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with CURALINC, LLC D.B.A. CURALINC HEALTHCARE, EYEMED VISION CARE ON BEHALF OF THE FIDELITY SECURITY LIFE INS. CO., UNUM INSURANCE COMPANY, KAISER FOUNDATION HEALTH PLAN INC, THE GUARDIAN LIFE INSURANCE COMPANY OF AMERICA, TELADOC HEALTH INC, VIDA, HEALTHJOY, UNITED OF OMAHA LIFE INSURANCE COMPANY and UNUM LIFE INSURANCE COMPANY OF AMERICA to pay Medical, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Long Term Care, Critical Illness, Hospital, Telehealth, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$1,584,105.
